# GRATA International ranked in Chambers&Partners Asia-Pacific 2020

Chambers&Partners has recently released its 2020 Asia-Pacific Guide, in which GRATA International has confirmed its status as one of the leading legal experts in Central Asia and Caspian region, with rankings in **Azerbaijan, Kazakhstan, Kyrgyzstan, Tajikistan** and **Uzbekistan**.

In Azerbaijan, GRATA International's team ranked in Band 3 for its full-service offering which proves a popular choice of counsel for clients operating across a diverse range of sectors, including pharmaceuticals, oil and gas, aviation, banking and technology.

**Ummi Jalilova**, director of Baku office, rises in the rankings after winning praise for her handling of a broad range of corporate and administrative law mandates.

The clients have described GRATA's Azerbaijan practice as *"very professional, experienced and smart team of lawyers working well under tight timelines"*.

In Kazakhstan, GRATA International confirmed its rankings across all practice areas:

- Corporate and Finance (Band 2)
- Dispute Resolution (Band 2)

GRATA International's Corporate and Finance team has received high remarks from the researchers and clients for its impressive regional practice providing local law, regulatory and due diligence support to international financial institutions involved in high-value inbound project financing.
