## Competition & Antitrust

Miyatov also advised an international cosmetics producer on an intra-group transaction. Another highlight shows the firm acting as the legal counsel for Uber on its business launch in Kazakhstan.

## Dispute Resolution & Litigation

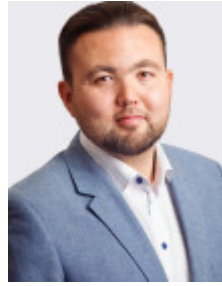
