China is the world's most populous country, with a population of around **1.404 billion**. **China's economy** is one of the world's **fastest-growing** with annual growth rates consistently above 6 percent. According to the World Bank, China's GDP grew from \$150 billion in 1978 to \$12.24 trillion by 2017. According to official data, China's GDP in 2018 was 90 trillion Yuan (\$13.28 trillion). Since 2010, China has been the world's second-largest economy by **nominal GDP** and since 2014, the largest economy in the world by **purchasing power parity** (PPP). China is also the world's largest exporter and second-largest importer of goods.
