production in such a way that issues unresolved by law are reflected in contracts - for example, guarantee retentions for the purpose of ensuring the quality of construction and transfer of a full package of executive documentation, issues of unilateral signing of defective acts for warranty repairs and much more;

- ▶ Development of a draft partnership (joint activity) agreement between a major land user and an investor on consolidation of investments for construction of an administrative and production complex on a land plot with a detailed division of responsibilities for collection of permission documentation, development of project documentation and implementation of construction, financing of all activities, and distribution of rights to the constructed facilities between the parties to the agreement. The agreement also regulated the distribution of shares in the rights to the facility in the event that its construction was not completed within the time frame provided for in the agreement, as well as the issue of forming a land plot and determining its purpose for servicing the constructed structure;
- ▶ A number of contracts were drafted for a major medical product manufacturer as part of the legal support of its business activities, including an agreement on payment of bonuses, marketing and advertising services agreements. In drafting the advertising services agreement, the company took into account the latest changes in the legislation on legal regulation of advertising, in particular, with regard to payment of a fee for placement (distribution) of advertising;
- ▶ A contract for business process analysis services was reviewed and finalized for the world's largest leader in the energy sector. The agreement was significantly amended to meet the requirements of Belarusian currency and tax legislation, as well as to minimize the risk of the counterparty defaulting on its obligations under the agreement;
- ▶ Making the necessary changes to the mandate agreement form used by the customs representative for a major logistics company. Among other things, the purpose of amending this form of contract was to minimize the risk of losses incurred by the customs representative due to declarants' bad faith actions;
- ▶ An audit of existing license agreements for use of trademarks and know-how transfer was conducted for a major manufacturer of building materials, taking into account the current requirements of Belarusian legislation and minimisation of possible risks for the client. In drafting the agreement our team took into account new practice of supervisory authorities (customs and currency control), recent changes in legislation and law enforcement practice, both in the field of intellectual property, customs and currency control, considered the agreements in complex with other agreements concluded by the same parties (e.g. supply contracts) and in general from the point of view of the productive activity of the client. The complexity and novelty of the project was that the agreements had to take into account the innovations currently being introduced by the customs authorities in their enforcement practices concerning the addition of royalties to the customs value of goods. It was therefore necessary to draft the agreements in such a way that the license fees could not be linked to the imported goods, even if the goods are marked with the same trademarks and produced using the same technology that the agreements provide to the client;
- ▶ On behalf of a major medical company, we analyzed the issue of proper documentation of the transfer of medical know-how and rights to use copyrights, as well as determined the most appropriate type of civil law agreement, taking into account the client's interests. As a result, a contract was drafted, taking into account not only the requirements of Belarusian legislation on intellectual property and trade secrets, but also currency and tax legislation;
- ▶ Legal support of the project to introduce foreign brands' winches into the Belarusian lift industry. A distribution

agreement, a winch supply contract, warranty and post-warranty service regulations, documents regulating the service center activities, and customer relations were developed. The complexity of the project was to determine and agree upon all necessary conditions of the contracts. A special challenge was the import of spare parts provided at no charge, with payment only for those parts that were not used for warranty repair, taking into consideration the strict currency requirements of the Belarusian legislation and the requirements relating to customs payment.
